### BRIDGING THE Gaps: Disability legislation, policies and best practices on access to Justice

#### CONTEXT

Across Member States of the European Union, persons with disabilities are yet to be granted full access to justice. They experience high rates of direct, indirect and structural discrimination, as well as intersecting forms of discrimination both in legislation and in policies and practices.

The UN Convention on the Rights of Persons with Disabilities (UN CRPD), alongside the European Charter of Fundamental Rights and other policies of the European Commission on disability, such as the European Accessibility Act, make up the essential international and regional legal framework with respect to the rights of persons with disabilities. However, each Member State is to adopt national legislation and policies aimed to respect, protect and fulfil the rights of persons with disabilities.

#### OBJECTIVES AND TARGET

On the basis of the previous results of the project, this workshop is aimed at improving the knowledge and awareness of legal practitioners on the situation of disability considering the most relevant



legislation, case law and policies related, as a condition to make them more competent in their role in the implementation of the European legislative framework regarding this field.

This workshop will bring together legal professionals, particularly notaries and lawyers, to compare theory and practice and detect which aspects may be improved in benefit of the people with disabilities and the coherence of the EU legal system.

## STRUCTURE

The session will be divided in three blocks. In the first one, about “International and the European legal framework on disability”, participants will have the opportunity to reflect on the International and European rules and policies, particularly on the CRPD and the Charter of Fundamental Rights of the European Union as well as on the main European Commission Policies on disability, including the European Accessibility Act. Even when the gender and children rights approaches will be incorporated throughout the workshops, a specific intervention on the subject is foreseen.

The second part will be devoted to the Spanish law. Legal professionals will address the national legal framework, comparing theory and practice and reflecting on the better way to improve their practices in benefit of the persons with disabilities.

Third, some of the best practices developed by legal professionals will be shared, for finish with a presentation of the main conclusions of the workshops that will be compared with the results of the three other workshops to be organized with legal professionals of different European countries.
